2. The Terms and Conditions of this giveaway are governed by the laws of the State of New South Wales.

4. Australia Day Beach Picnic Hamper Giveaway (“the giveaway”) commences Monday 5<sup>th</sup> January 2026 at 9am AEDST.
5. The closing time for entering the competition is Thursday 22<sup>nd</sup> January 2026 at 5pm AEDST
6. The following individuals are **ineligible** to enter the Promotion:
